Ensure the Future of Medi-Cal Coverage for Adult Day Health Care

It couldn't be more simple. AB 1552 (Lowenthal) will codify CBAS as a Medi-Cal benefit, ensuring that coverage for Adult Day Health Care will continue to be available to those who are eligible. This Bill recently passed the state senate and assembly without a single dissenting vote! Now it's up to the Governor.

While the Department of Health Services opposes the bill, stating that they feel it is "unnecessary," the Governor has not yet made a decision. Your support and the support of your grassroots networks are essential.

Please sign AB 1552 (Lowenthal), which would place the Community-Based Adult Services (CBAS) program into state statute, ensuring that Medi-Cal coverage for Adult Day Health Care will be available for those who are eligible. This legislation would ensure continuity of care to some of California's most vulnerable citizens.
