His portfolio consists of an array of community-based services including: Managing non-KP facility Claims (members admitted to non-KP facilities), Referrals (members requiring higher level of care unavailable at KP

facilities, Community Care Program (program focused on assisting high-risk members in the community to effectively self-manage), Transportation (to and from KP and non-KP facilities), DME (for KP members and non-members), Dialysis Centers, and CCS (California Children Services). Prior to Kaiser Permanente, he worked at various facilities managing home health and hospice services, including Sutter Health in the Bay area.

Sophay Duch (Pai), LCSW

Sophay Duch is a Licensed Clinical Social Worker (LCSW) serving older adults in Alameda County at LIFE ElderCare. She graduated from the University of Southern CA with a Master of Social Work with a concentration in Community, Organization, and Business Innovation. Sophay started practicing as a Medical Social Worker focusing on older adults, end of life care, and counseling individuals and families. The Covid-19 pandemic impacted the healthcare industry greatly. Many patients passed away, families and communities fractured due to isolation, and taking care of patients became more difficult, as did supporting the mental and emotional health of staff. As a manager, Sophay had to ensure that health care services were being delivered to patients and also support and motivate staff to continue to serve. At LIFE ElderCare Sophay leads a team that provides case management services to a diverse population and ages that range from 60-100 years old. Applying an interdisciplinary and systems based approach to her work has helped her develop culturally sensitive interventions. In July 2022 LIFE ElderCare partnered with Kaiser Oakland in the efforts to deliver its mission to help older adults age in place. The Kaiser Oakland and LIFE ElderCare Pilot program is designed to test the integration of Community Based Organizations (CBOs) into the Kaiser care team through the Kaiser's Thrive Local Initiative/UniteUs Platform, working with select Kaiser departments and a small group of SSC's member organizations, led by LIFE ElderCare, to address the unmet social needs of Kaiser Permanente and non-Kaiser member including food/meals, transportation, isolation, lack of caregiver support, and additional supportive services for the home. Sophay utilizes her mental health clinical training to meet people where they are at and empower each of them to connect to the resourses that can increase their quality of life. Her goal is to contribute to the collective wellness of the community one person at time, one organization at a time.

Sonya Frost

Sonya Frost began her professional career with the Alameda County Social Services Agency in the Workforce and Benefits Administration Department in 1990. This position was the first of many that would lead her to a career in Social Work for the 32 years. During her tenure with Alameda County SSA, Sonya also worked in the Department of Children and Family Services for 26 years in 15 different programs as a Child Welfare Worker, Induction Trainer, MSW Intern & Clinical Licensing Coordinator, Child Welfare Supervisor, Facilitator, Program Manager and Division Director. Although Child Welfare was her passion, she became curious about the disabled and older adult population and expressed an interest in working with this population. In November 2020, a door of opportunity opened, and Sonya took the leap over to the Department of Adult and Aging Services. Serom and her team have worked closely with the County's medical facilities to creatively troubleshoot and facilitate discharges of some of their most complex long-term patients to stable long-term housing and care settings, as well as decrease unnecessary utilization of inpatient and emergency services. Serom has a passion for helping individuals learn their rights and resources related to healthcare, housing, and bridging the gaps in service by helping clients to access Medi-Cal Waiver programs, affordable and accessible housing, and build
